1 I, ROSS D. MURRAY, declare and state as follows:

2 1. I am employed as a Vice President of Securities by Gilardi & Co. LLC (“Gilardi”),
3 located at 1 McInnis Parkway, Suite 250, San Rafael, California. Pursuant to this Court’s May 28,
4 2025 Order Re Preliminary Approval and Notice (ECF 128) (the “Notice Order”), Gilardi was
5 appointed as the Claims Administrator in connection with the proposed Settlement of the above-
6 captioned action (the “Action”). I oversaw the notice services that Gilardi provided in accordance
7 with the Notice Order.

8 2. I submit this declaration as a supplement to my previously filed declaration, the
9 Declaration of Ross D. Murray Regarding Notice Dissemination, Publication, Digital Media
10 Campaign, Establishment of Call Center Services and Website, and Requests for Exclusion
11 Received to Date (ECF 134-3) (the “Initial Mailing Declaration”). The following statements are
12 based on my personal knowledge and information provided to me by other Gilardi employees, and,
13 if called as a witness, I could and would testify competently thereto.

14 **CONTINUED DISSEMINATION OF NOTICE**

15 3. As more fully detailed in the Initial Mailing Declaration, as of July 17, 2025, Gilardi
16 had mailed or emailed a total of 91,275 copies of the Summary Notice of Proposed Settlement of
17 Class Action (the “Summary Notice”). In addition, one institution reported that they anticipated
18 sending Summary Notices via email to 204,632 potential Class Members. *See* Initial Mailing
19 Declaration, ¶11.

20 4. Since July 17, 2025, Gilardi has mailed or emailed an additional 57,422 Summary
21 Notices and 38 copies of the Notice of Pendency and Proposed Settlement of Class Action (the
22 “Notice”) and Proof of Claim and Release form (the “Proof of Claim”) (collectively, the “Claim
23 Package”) to potential Class Members and their nominees in response to requests from potential
24 Class Members, brokers, and nominees and as a result of mail returned as undeliverable for which

1 new addresses were identified and re-mailed to those new addresses.¹ Therefore, as of October 1,
2 2025, Gilardi has directly mailed or emailed a total of 148,697 Summary Notices and 38 Claim
3 Packages to potential Class Members and nominees.

4 **UPDATE ON DIGITAL MEDIA CAMPAIGN**

5 5. On June 25, 2025, Gilardi commenced the digital media campaign outlined in the
6 Declaration of Carla Peak Regarding Settlement Notice Plan (ECF 127-5). This campaign used
7 programmatic display advertising to allow internet advertisements to be directed specifically to
8 likely Class Members. A summary of the number of digital media impressions achieved over the
9 respective platforms between June 25, 2025, and the completion of the campaign on July 27, 2025,
10 is attached hereto as Exhibit A.

11 **UPDATE ON CALL CENTER SERVICES AND WEBSITE**

12 6. Gilardi continues to maintain the toll-free telephone helpline (1-888-710-2846) to
13 accommodate inquiries about the Settlement from potential Class Members. Gilardi also monitors
14 the case-dedicated e-mail address, info@ZoomSecuritiesSettlement.com. Gilardi endeavors to
15 respond timely to each telephone and e-mail inquiry and will continue to respond to Class Member
16 inquiries via the toll-free telephone helpline and case dedicated e-mail address until the conclusion
17 of the administration.

18 7. Gilardi also continues to maintain the website dedicated to the Settlement,
19 www.ZoomSecuritiesSettlement.com (the "Settlement Website"), to assist potential Class
20 Members. Following Lead Counsel's filing of their briefing in support of the Settlement on July
21 18, 2025, Gilardi posted to the Settlement Website copies of the papers in support of Lead
22 Plaintiff's Motion for Final Approval of Class Action Settlement and Approval of Plan of
23 Allocation and Lead Counsel's Motion for an Award of Attorneys' Fees and Expenses and Award
24 to Lead Plaintiff Pursuant to 15 U.S.C. §78u-4(a)(4). Gilardi will continue operating, maintaining

1 and, as appropriate, updating the Settlement Website until the conclusion of the administration of
2 this Settlement.

3 **CLAIMS RECEIVED TO DATE**

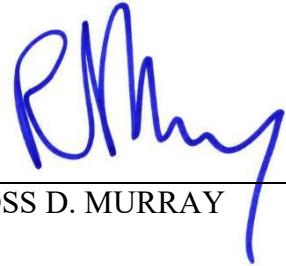
4 8. Pursuant to the Notice Order, the Summary Notice and Notice informed potential Class
5 Members that Proofs of Claim must be postmarked or submitted online on or before September
6 16, 2025. As of October 1, 2025, Gilardi has received 207,443 timely Proofs of Claim and 267
7 late Proofs of Claim.

8 **REQUESTS FOR EXCLUSION RECEIVED TO DATE**

9 9. Pursuant to the Notice Order, the Notice informed potential Class Members that
10 written requests for exclusion from the Class are to be mailed to Gilardi such that they are
11 postmarked or received no later than September 18, 2025. At the time of the Initial Mailing
12 Declaration, Gilardi reported that it had not received any requests for exclusion. *See* Initial Mailing
13 Declaration, ¶17.

14 10. Since the Initial Mailing Declaration was executed, and as of the date of this
15 declaration, Gilardi has received eight requests for exclusion, redacted copies of which are attached
16 hereto as Exhibit B.

17 I declare under penalty of perjury that the foregoing is true and correct and that this
18 declaration was executed this 1st day of October, 2025, at San Rafael, California.
